## **1. INTRODUCTION**

The purpose of this Bid is to invite Service Providers to submit their proposals to provide and deliver overhead projectors, gaming consoles and tablets for children in the Foundation Phase at 667 public libraries in nine (9) provinces participating in the Mzansi Libraries On-Line (MLO) Project.

## **2. OBJECTIVES**

The business objective for the required services is to deliver overhead projectors, gaming consoles and tablets for children in Foundation Phase for some of the 667 public libraries participating in the NLSA's Mzansi Libraries On-Line (MLO) Project, MLO project is hosted by the National Library of South African in partnership with the nine (9) provincial Library Services and National Department of Arts and Culture and funded by the Bill and Melinda Gates Foundation Global Library Programme.

## **3. BACKGROUND**

The Mzansi Libraries On-Line (MLO) is the programme of the National Library of South Africa. The MLO Project focuses on strengthening and enhancing public libraries in South Africa through the provision of access to information, technologies and relevant training of library staff from 667 selected public libraries in all the nine (9) provinces. The technologies provided include free access to internet, computers, peripheral devices and mobile devices such as laptops, tablets and gaming consoles (X-Box, Play Station, Leappad and See Box).

The Mzansi Libraries On-Line Project's promotes access to Information Technology through the use of ICT equipment thereby creating a public library environment where community will have access to free information within their public library.

### **3.1 SCOPE OF WORK**

3.1.1 There are 667 participating libraries in the MLO project, those libraries were categorized in three categories 1, 2 and 3.

3.1.2 The scope of the required services shall include the delivery of overhead projectors to 632 libraries, gaming consoles to 202 libraries and tablets for kids in foundation phase to 667 libraries as per table below:

**5. TIME FRAME**

5.1 All delivery must happen as per an official order or Service Level Agreement.

**5.2 Service Level Agreement**

On approval/acceptance of the appointment, the service provider must be prepared to enter into and sign a Service Level Agreement with the National Library of South Africa (NLSA) in compliance with the policies, procedures and requirements of the NLSA and all statutory requirements.

**6. EVALUATION CRITERIA**

**6.1 Format of bids**

The attached bid documents must be completed and each page initialled by bidders' authorised representatives and witnesses. All the compulsory documents as listed below must be provided.

All bidders who have state employees as shareholders and or directors in their companies must submit with the bids the permission to conduct remunerative work outside the public service as contemplated in Section 30 of the Public Service Act.**

**6.2 Pre-qualification of Bids (Stage 01)**

The following mandatory requirements must be met to qualify for this tender:

The Evaluation Committee will allocate points out of 100 for functionality according to the criteria set out below. Bidders who fail to score **70 points** for functionality will be considered as having submitted a non-responsive bid and will not be considered for further evaluation.

## **7. BASIS OF BIDS**

### THE NATIONAL INDUSTRIAL PARTICIPATION PROGRAMME

#### INTRODUCTION

The National Industrial Participation (NIP) Programme, which is applicable to all government procurement contracts that have an imported content, became effective on the 1 September 1996. The NIP policy and guidelines were fully endorsed by Cabinet on 30 April 1997. In terms of the Cabinet decision, all state and parastatal purchases / lease contracts (for goods, works and services) entered into after this date, are subject to the NIP requirements. NIP is obligatory and therefore must be complied with. The Industrial Participation Secretariat (IPS) of the Department of Trade and Industry (DTI) is charged with the responsibility of administering the programme.

#### PILLARS OF THE PROGRAMME

1.1 The NIP obligation is benchmarked on the imported content of the contract. Any contract having an imported content equal to or exceeding US\$ 10 million or other currency equivalent to US\$ 10 million will have a NIP obligation. This threshold of US\$ 10 million can be reached as follows:

- (a) Any single contract with imported content exceeding US\$10 million. or
- (b) Multiple contracts for the same goods, works or services each with imported content exceeding US\$3 million awarded to one seller over a 2 year period which in total exceeds US\$10 million. or
- (c) A contract with a renewable option clause, where should the option be exercised the total value of the imported content will exceed US\$10 million. or
- (d) Multiple suppliers of the same goods, works or services under the same contract, where the value of the imported content of each allocation is equal to or exceeds US\$ 3 million worth of goods, works or services to the same government institution, which in total over a two (2) year period exceeds US\$10 million.

1.2 The NIP obligation applicable to suppliers in respect of sub-paragraphs 1.1 (a) to 1.1 (c) above will amount to 30 % of the imported content whilst suppliers in respect of paragraph 1.1 (d) shall incur 30% of the total NIP obligation on a *pro-rata* basis.

1.3 To satisfy the NIP obligation, the DTI would negotiate and conclude agreements such as investments, joint ventures, sub-contracting, licensee production, export promotion, sourcing arrangements and research and development (R&D) with partners or suppliers.

1.4 A period of seven years has been identified as the time frame within which to discharge the obligation.

#### **REQUIREMENTS OF THE DEPARTMENT OF TRADE AND INDUSTRY**

2.1 In order to ensure effective implementation of the programme, successful bidders (contractors) are required to, immediately after the award of a contract that is in excess of **R10 million** (ten million Rands), submit details of such a contract to the DTI for reporting purposes.

2.2 The purpose for reporting details of contracts in excess of the amount of R10 million (ten million Rands) is to cater for multiple contracts for the same goods, works or services; renewable contracts and multiple suppliers for the same goods, works or services under the same contract as provided for in paragraphs 1.1.(b) to 1.1. - 2 It serves as a declaration to be used by institutions in ensuring that when goods and services are being procured, all reasonable steps are taken to combat the abuse of the supply chain management system.
- 3 The bid of any bidder may be disregarded if that bidder, or any of its directors have-
  - a. abused the institution's supply chain management system;

**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *per se* prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
  - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
  - b. cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.
- 4 This SBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

<sup>2</sup> Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
