1. BACKGROUND

- 1.1 The National Library of South Africa, hereafter referred to as NLSA, is a world class African National Library and Information Hub. The NLSA is responsible for collecting, recording, preserving, and making available the national documentary heritage of South Africa. The NLSA promotes awareness, appreciation and access to published documents, nationally and internationally and in doing so contributes to the development and prosperity of South Africa. The NLSA has campuses in Pretoria and Cape Town.

2. SCOPE OF WORK

- 2.1 This is a once off purchase and supply of three standard steel wheelchairs with the following features as specification: Two wheelchairs shall be delivered to Cape Town whilst one is delivered to Pretoria
- Weight capacity: 100kg
 - Nett Weight: 17kg
 - Overall weight: 46cm
 - Seat width: 46cm
 - Special feature: Standard steel wheelchair

Frame type & finish: Steel frame with powder coating

Arm & footrest: Fix armrest, fixed footrest

Front & rear wheels: Front 20cm solid wheels; Rear 60cm solid wheels

Upholstery: Canvas seat and backrest

Brakes: Handbrake

NB. The manufacturer's manual to confirm above features must form part of bid submission.

3. NLSA'S RIGHTS

7.2.1 Preference Point System

In terms of Regulation 5 of the Preferential Procurement Regulations of 2022/23, Gazette Number 47452 dated 4 November 2022 pertaining to the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) responsive bids will be adjudicated by the State on the 80/20-preference point in terms of which points are awarded to bidders based on :

- The bid price (maximum 80 points)
- Specific Goals (maximum of 20 points):

Bid price

The following formula will be used to calculate the points out of 80 for price in respect of an invitation for a tender, inclusive of all applicable taxes.

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

P_s = Points scored for price of tender under consideration;

P_t = Price of tender under consideration; and

$P_{\min}$ = Price of lowest acceptable tender.

Specific Goals (maximum of 20 points):-

20 points for 100% Black owned companies,

10 points if the company is not 100% black owned.

The Central Supplier Database report will provide evidence of Black Ownership status.
