TERMS OF REFERENCE TO REQUEST QUOTATION FOR SIGN LANGUAGE INTERPRETATION SERVICES TO THE NATIONAL LIBRARY OF SOUTH AFRICA (NLSA)

1. BACKGROUND

The National Library of South Africa, hereafter referred to as NLSA, is a world class African National Library and Information Hub. The NLSA is responsible for collecting, recording, preserving, and making available the national documentary heritage of South Africa. The NLSA promotes awareness, appreciation and access to published documents, nationally and internationally and in doing so contributes to the development and prosperity of South Africa. The NLSA has Campuses in Pretoria and Cape Town.

2. SCOPE OF WORK

The NLSA seeks to appoint a services provider to provide sign language interpretation services for two and half days during the 3rd Biennial National Reading Summit to be held at Umfolozi Hotel Casino Convention Resort, Empangeni, KwaZulu Natal. The exact address and venue will be provided to the winning service provider. The service required are 2.5 days (two and half days) or 20 hours of sign language interpretation services from English to sign language.

EVALUATION CRITERIA

3. Standard bid document - Pre- evaluation:

- 3.1. All Bidders must be registered on the National Treasury Central Supplier Database (CSD) and must attach a copy of the most recent report.
- 3.2. Complete SBD 4 and 6.1 forms

4. DURATION OF THE PROJECT

The appointed service provider shall supply NLSA with products as indicated within 7 (seven) days after a Purchase Order is issued as per the specifications in the RFQ.

6. NLSA'S RIGHTS

- 7.6 The quotations shall remain valid for a period of 60 days and may be extended at the discretion of the NLSA.

8. PRICING

Preference Point System

In terms of Regulation, 5 of the Preferential Procurement Regulations of 2022/23, Gazette Number 47452 dated 4 November 2022 about the Preferential Procurement Policy

Framework Act, 2000 (Act 5 of 2000) responsive bids will be adjudicated by the State on the 80/20-preference point in terms of which points are awarded to bidders based on :

- The bid price (maximum 80 points)
- Specific Goals (maximum of 20 points):

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

Bid price

The following formula will be used to calculate the points out of 80 for price in respect of an invitation for a tender, inclusive of all applicable taxes.

8.1 3 Specific Goals (maximum of 20 points):

- Locality = 20 Points if the bidder is in KwaZulu Natal and 10 points if the bidder not based in KwaZulu Natal (10 points).

P_s = Points scored for the price of tender under consideration;

P_t = Price of tender under consideration; and
